

Young Actors Camp
Personal Appearance in a Film Production Release Form
Participating in the creation of actors reel, video diary, & camp movie

In connection with my participation in the Young Actors Camp ("Camp"), I acknowledge that I may be filmed or videotaped. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I grant to Inspire Me, Inc. and Young Actors Camp and the agents, successors, assigns and licensees (collectively, "YAC") the universal and perpetual right to use, and to grant others the right to use, my name, likeness, photographs, voice, personal characteristics and other personal identification and to portray me in any way, and to make use of any incidents filmed or taped during Camp whether or not scripted, in any and all manner and media whatsoever, now known or hereafter devised, including, without limitation, home video and electronic media. The rights granted to you herein, however, shall not permit exercise of these rights as a direct commercial endorsement by me of any product or service (other than the Camp or the Film, as hereinafter defined) without first obtaining my consent. In the event a motion picture is created based on the Camp or arising out of scenes performed in with the Camp or events taking place within the Camp (collectively referred to as the "Film"), YAC may create and include therein such actual or fictional incidents, scenes, situations, dialogue, events, characters, names, biographical information and other material as YAC may, in its sole discretion, consider proper or necessary and YAC is free to edit, change and dub any recordings of me with any other material (for any purpose, including without limitation, for humorous or satirical effect).

I hereby release YAC from all liability and obligations to me of any and all nature whatsoever arising out of my participation in the Camp or statements made by me or others in connection with the Camp, the Film, or the exercise of the rights granted above, including, without limitation, from any liability for violation of rights of privacy, publicity, defamation, libel or slander or any similar right. I agree that I shall be entitled to no consideration or compensation as a result of the exercise of the rights granted herein or my participation in the Camp or the Film and that YAC may rely upon this release in producing, distributing and exploiting the Film. If the Film becomes subject to any collective bargaining agreement, I agree that I shall be entitled only to the minimum applicable scale compensation set forth in such agreement and YAC shall be entitled to the maximum benefits under the agreement. Because YAC is incurring expenses in reliance of this release, I will never revoke it.

The Film and all performances rendered in connection with the Camp shall be considered a work made for hire under the United States Copyright Act and wholly owned by YAC. If for any reason, any part thereof is not held to be a work made for hire, then I irrevocably grant and assign, free and clear of any claims, all of my rights and interest therein to YAC, exclusively and perpetually, throughout the universe, in any and all media, now known or hereafter devised, including, without limitation home video and electronic media. YAC shall have the right, but not the obligation, to exploit the Film, in whole or in part, and to vend, copy, publish, reproduce, record, transmit, telecast by radio, television, or computer, perform, and photograph with or without sound the Film in any and all media and shall have the right to exploit the Film in ancillary markets, worldwide, including all merchandising rights. I hereby waive any so-called "moral-rights" which may now or hereafter be recognized in connection with the Film (such as the right to approve any revisions, deletions or abridgements, etc.). I acknowledge I have received equitable remuneration for rental rights.

I hereby acknowledge and agree that in the event of any dispute arising out of this release, my appearance in the Film, or in connection with the production, distribution or exploitation of the Film, I will first submit in writing to YAC the details thereof. YAC shall then have the absolute right and option, by giving notice to me within 10 business days after receipt of my notice, to require that the matter be resolved by binding arbitration in Los Angeles, California before a single arbitrator acting under rules of, and appointed by, the American Arbitration Association. If YAC does not elect to enter into arbitration, I may commence a legal action if I choose, but solely in the state or federal courts located in Los Angeles, California. In the event any such arbitration or legal action is commenced, I hereby acknowledge and agree that the laws of the State of California shall govern, and that the prevailing party will be awarded the reasonable attorneys' fees and costs it incurs with regard to the arbitration or court action. This release shall be freely assignable by YAC.
